

## CTPAT COLLABORATION AGREEMENT

As a result of the tragic event of September 11, and other events arising at the border, the main focus of US Customs is to prevent the criminal / terrorist use of supply chain import or export to the United States. The CTPAT program (Custom Trade Partnership Against Terrorism) is a program that supports the security objectives of US Customs. We require your cooperation in completing the following agreement with the purpose of mutual commitment to strengthening security in the supply chain.

THIS AGREEMENT HAS THE PURPOSE TO TRADE PARTNERS: **CEMPRO LLC** JOINTLY COLLABORATES IN THE DEVELOPMENT AND IMPLEMENTATION OF THE NECESSARY PROCEDURES TO REINFORCE CTPAT SECURITY PROGRAM.

This agreement is concluded by **CEMPRO LLC** part represented in this act by the **GENERAL MANAGER C. ALMA FLORES**, according to the terms and following statements:

### STATEMENTS

I.- Declares **CEMPRO LLC**, which is a legally constituted company, and has the necessary infrastructure to safeguard the goods. States that maintain the security policies and procedures required by CTPAT program and which are necessary for the protection of finished good products

II. The BUSINESS PARTNER declares to maintain a commercial relationship with **CEMPRO LLC** and that requires foreign trade services. Also states the BUSINESS PARTNER is regulated by the CTPAT program.

III. Both sides expressed their intention to work together in the implementation of standards of CTPAT program, aimed at strengthening its logistics operations in a safe manner to prevent the smuggling of: explosives and chemical weapons, drug trafficking in their shipments import or export to or from the United States subject to the following clauses:

## CLAUSES

- A. Both parties agree to communicate to each other any anomaly that threatens or could threaten the integrity of the shipment and/or security policies of the CTPAT program.
- B. Establish close communication of both sides so when the event that a security incident occurs, the two sides can get a quick and efficient response.
- C. Communicate to each other and as allowed under the rules and policies of each company, practices and procedures that have proven use in the reduction and prevention of risks and threats in the supply chain, while maintaining strict confidentiality of the information shared.
- D. Each of the parts chooses a coordinator for security matters, under this agreement.
- E. The staff responsible for collaborating and working in the joint implementation of this agreement, absolutely will continue under the direction and dependence of business origin, so it will not create any additional employment nexus with the other part.
- F. The company must work under the norms of the law to which the entity belongs and ensure that the goods and / or services are not extracted, produced or manufactured, totally or partially, with prohibited forms of labor, for example, forced labor, imprisoned, hired or child labor than their workers.
- G. The company must work under the rules of the law and avoid acts of corruption and money laundering.
- H. This agreement may be revised, added or expanded at any time, by agreement between both parties; with the aim of strengthening the security of goods transported and preventing risks in its entirety.
